# **WHAT DOES IT MEAN TO COMPLY WITH SCHOOL POLICIES AND PROCEDURES?**

- Students will comply with school routines.
- Students will participate in program of instruction.
- Students will stay in class until the bell goes.

# **WHAT DOES IT MEAN TO COMPLY WITH SCHOOL ROUTINES?**

- Students will follow classroom and school expectations.
- Students will have the required materials for learning.
- Follow safety expectations at school.

# WHY DO STUDENTS NEED TO COMPLY WITH ROUTINES?

- Following classroom expectations and procedures reduces instances of disruption in class.
- Having required materials ensures students can access curriculum and succeed in their learning.
- Being safe, ensures students and staff feel safe.

# **WHAT DOES IT MEAN TO PARTICIPATE IN A PROGRAM OF INSTRUCTION?**

- Complete curriculum work set by your classroom teacher.
- Attempt all curriculum work set by your teacher.
- Complete drafts on time.
- Complete any set homework.

# **WHY DO STUDENTS NEED TO PARTICIPATE IN PROGRAM OF INSTRUCTION?**

- Participating in a program of instruction ensures students are focused on quality learning.
- Students are engaged in curriculum tasks and it builds resilience.

# **WHAT HAPPENS IF YOU DO NOT COMPLY WITH ROUTINES AND INSTRUCTIONS IN THE REAL WORLD?**

- Failure to comply with policies and procedures in the workplace can result in:
  - Loss of job (warning)
  - Injury (self and others)
  - Consumption (wasting) of time and money
  - Negative reference given
  - Legal implications



# **WHAT HAPPENS IF STUDENTS DO NOT FOLLOW SCHOOL POLICIES AND PROCEDURES?**

- Student will complete Form 1 with teacher.
- Students that breach Form 1 will complete a Form 2 with the teacher and subject HoD.
- If students breach Form 2 then relevant DP will intervene.

# WHAT DOES THAT MEAN FOR STUDENTS?

- Students will meet with their teacher and subject HoD to discuss behaviour.
- Student, teacher and HoD will develop specific strategies to support the student engaging in curriculum tasks.
- If behaviours continue despite HoD and teacher intervention then relevant DP will intervene.

# **WHEN STUDENTS MAKE POSITIVE CHOICES- THERE ARE POSITIVE OUTCOMES**

  - Positive Postcards
  - Phone call home
  - Positive encouragement / reinforcement
