## VET Options at ESHS

- Certificate courses offered by the school as RTO (Registered Training Organisation)
- Certificate courses offered by outside RTO's that qualify for VETIS funding
- Certificate courses offered by outside RTO that incur a fee for service

## What is VETiS funding?

- Vocational Education and Training in Schools (VETiS) is delivery of nationally recognised qualifications to school students, providing them with the skills and knowledge required for employment in specific industries.
- VETiS qualifications can be undertaken in years 10, 11 and 12 and can count towards the Queensland Certificate of Education.
- The VET investment budget provides funding for students to complete one VETiS qualification listed on the Queensland Training Subsidies List while at school.

### What is Fee for Service?

- Fee for Service Training is an option when programs are not accessible via Vetis. RTO's can deliver training at a heavily discounted rate to students while enrolled in school.
- These programs are generally Certificate III level qualifications and do involve work placement.

## Please Note! (Year 10)

- If you choose to enrol in a VETiS funded course (external RTO) for next year, you will not be able to access this funding for other courses.
- This is a one time funding only.

## SAT -School-based Apprenticeships and Traineeships

Students are trained in the workplace, with a training organisation while continuing to study towards their QCE.

Students are paid for time spent working with their employer and are expected to work 7.6 hours per week.

Minimum of 375 hours (50 days) per 12 month period.

The User Choice program provides a public funding contribution towards the cost of training and assessment services for eligible Queensland apprentices and trainees.

These are categorised in priority areas.

- Priority One (100% subsidised)
- Priority Two (87.5% subsidised)
- Priority Three (75% subsidised)

### USI – Unique Student Identifier

- A USI is required for students to enrol in a VET course. It gives you an online record of your VET training (also carries over to tertiary studies).
- Please note all students will need a verified USI to be supplied to the school prior to commencement of year 10.
- Students will be spoken to about this process and issued with the required form.

### All Year 10 students will undertake Certificate II Skills for Work and Vocational Pathways in 2022

- There is a work experience component of 20 hours minimum
- The completed Certificate II contributes to completed core and 4 credits towards students QCE
- From 2022, the course doesn't not contribute to the literacy and numeracy component of a QCE.
